- (3) The School shall admit in Class I, to the extent of <u>25%</u> of the strength of that class, children belonging to weaker section and disadvantaged group in the neighborhood and provide free and compulsory elementary education till its completion. Provided further that in case of pre-primary classed also, this norms shall be followed.

- (16) The schools furnished such reports and information as may be required by the Director of Education/District Education Officer from time to time and complies with such instructions of the State Government/Local Authority as may be issued to secure the continued fulfillment of the condition of recognition or the removal of deficiencies if working of the school.
- (17) Renewal of Registration of Society if any, be ensured.
- (18) Other conditions as per Annexure "III" enclosed.
- (19) The School shall always be run as a private institutions and will not claim for any grants-in-aid or seek Provincialisation by the Government in future.
